- Oahu Good Food Pledge: Oahu's reliance on imported food is a long-running and well-known problem.
 Mayor Blangiardi and his team is committed to tackling this challenge by encouraging increases in both the demand and supply side of institutional food purchasing, aiming for growth and balance in Agriculture, an important sector of our island economy.
- Meet your City Officials: Mayor Blangiardi and his team will be on the road to visit communities around Oahu. DEPARTMENT ISSUES FOLLOW-UP

- Pedestrian Safety: Regarding Vision Zero: DTS: The Vision Zero Action Plan is still under development.
 The Department of Transportation Services held a Vision Zero Action Plan public workshop in December 2022. The materials from that public meeting, including a recording of the meeting, are available on the project website at www.honolulu.gov/completestreets/visionzero. Further community outreach is ongoing, and a second public meeting is planned for late 2023. Please visit the project website for more information and to provide input.
- 2. <u>Traffic Signals</u>: Regarding Pali Highway traffic signals: **DTS**: Pali Hwy is under State DOT jurisdiction. DTS will continue to monitor and work with the SDOT.

- 3. <u>Parking Meters:</u> Regarding parking meter replacements: **DTS:** The Honolulu On-Street Parking Systems Upgrade Project, Solicitation No. RFP-DTS-1669205 was released for the purchase of single-space meters, pay-stations, and/or other innovative solutions, to be used as payment equipment for on- and off-street parking spaces. The new, efficient, and cost-effective parking meter equipment provides for wireless connectivity, accepts payment through credit-card, account-based systems, and/or coin transactions. Competitive sealed proposals were received February 23, 2023 and are being evaluated.
- 4. <u>Burnt Homes:</u> Regarding burnt homes and who is responsible for them: **DPP:** The City's Department of Planning and Permitting would conduct an inspection for fire damage if addresses are provided and notify the owner to take appropriate action.
