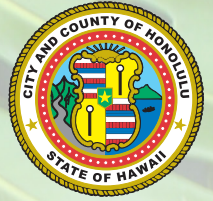

Rental and Utility Relief Program Portal Temporarily Re-Opened



The City's Rental and Utility Relief Program will temporarily reopen for 8,000 new applications on October 3 at 2 p.m., at oneoahu.org/renthelp. This will be funded with \$31 million in State and Local Fiscal Recovery Funds and \$4.5 million in reallocated funds from the U.S. Department of Treasury's Emergency Rental Assistance Program.

If you have questions about the reopening, please contact the City's Office of Economic Revitalization (OER) at (808) 768-CITY (2489). Call center hours will be extended to 5:30 p.m. to help renters with their questions. To assist applicants, OER recommends taking the following steps to prepare for submitting an application:

- Start gathering needed documents, including a government-issued photo ID, overdue rent or utility bills, tax returns, and proof of financial hardship since March 2020. A household must also earn at or below 80% of the area median income.
- The Program is prioritizing new applicants and renters should apply only once. Duplicate applications will reduce the number of renters who receive help and slow down processing.

- Renters who have received less than 18 months of support from RURP can also request additional funds directly from Catholic Charities Hawai‘i (CCH) at rurp.recert@catholiccharitieshawaii.org or the Council for Native Hawaiian Advancement (CNHA) at RURP@hawaiiancouncil.org, on or after October 3.
- Please do not reapply at oneoahu.org/renthelp and do not reach out to CCH or CNHA to recertify before October 3. Requests for recertification received before October 3 at 2 p.m. may not be honored.

For both new applications and recertifications, CCH and CNHA may request additional information and documentation to validate a household’s situation. We encourage renters to review eligibility information in the FAQ at oneoahu.org/renthelp.

City Now Accepting Grants in Aid Applications!

City announced that qualified nonprofit organizations can now apply for grants available through the City's Grants in Aid (GIA) program.

The City Charter-mandated GIA fund administered by the Department of Community Services (DCS) was established by a voter initiative to serve economically and/or socially disadvantaged populations, or provide services for public benefit in the areas of arts, culture, economic development, or the environment.

The city is mandated by a Charter Amendment to set aside one-half of one percent of general funds for Grants in Aid for the following two categories:

Public Services

Funds in this category must be used to support qualified public services and programs for the target populations deemed by the city to be most vulnerable such as seniors, persons with disabilities, children, victims of domestic violence, people experiencing homelessness, and those suffering from the effects of substance abuse or poor mental health.

Arts, Culture, and Community / Economic Development and the Environment

Funds in this category must be used to support the sustainable improvement in the well-being and quality of life of local communities, especially low- to moderate income areas. Projects could assist programs that create, develop and empower community based organizations, provide planning, organizational support, and technical assistance to organizations, support financial literacy programs and services, support micro-enterprise and business training, and support programs that promote cultural or environmental enhancement, protection or awareness.
